



## MY TWO DOGS/TRAINING ANGELS TRAINING POLICIES

Class size is limited and limits are strictly observed. Class registration is on a first come first served basis. Your place in class cannot be guaranteed until payment is made.

### **PAYMENT/REFUND POLICY**

Payment is required in full prior to class. There are no refunds; you may transfer the class fee towards another class or another service provided by My Two Dogs. You may pay by cash, check, Visa or MasterCard. Identification is required for payment by checks and there is a \$25 fee for returned checks.

### **VACCINATION/HEALTH**

All dogs entering into all classes but puppy class must have current vaccinations against Rabies and DHPP. Bordetella is not required for class but suggested for additional protection. You must submit a copy of your dog's vaccinations records prior to class. Dogs will not be admitted into the facility until we have proof of vaccinations.

### **EQUIPMENT**

#### **COLLARS & LEASHES**

All dogs must be on leash when entering and exiting My Two Dogs. A flat collar (or a harness) and a 4-6 foot leash is required for class. Head halters, choke, pinch collars, sporn harnesses and flexi-leads will not be permitted in class.

If you like, you may purchase your equipment from My Two Dogs at a 10% discount during the length of the class.

**REWARDS/TREATS**

You are expected to bring to class small soft treats and/or toys to reward your dog with during class. Treats will also be available for purchase from My Two Dogs with a 15% discount during the length of the class.

**EXTRAS**

Please bring a blanket or towel to class for your dog to relax on. You may also want to bring a fanny bag or small plastic bags to hold your treats. You should also consider bringing a stuffed Kong toy or stuffed bone as well.

**AGGRESSION**

Any dog that shows signs of aggression to people and/or dogs during class will be removed from class. You will be counseled on how the situation should be handled.

**FAMILY MEMBERS**

Class is limited to 2 people per dog. To keep training consistent, one person will be responsible for handling the dog during the class. If you bring your child to class, your child will be expected to be well behaved and under your supervision at all times. If your child becomes disruptive, your child will be asked to leave the training area.

**MISC.**

Any photos that are taken of yourself and your dog may be used for training materials and publicity purposes by My Two Dogs and Training Angels.

Make sure your dog has been exercised and has had a chance to eliminate prior to class. It is your responsibility to clean up any accidents inside or outside the training facility. We will have cleaning supplies available.

## TRAINING AGREEMENT/LIABILITY WAIVER

I acknowledge that My Two Dog's premises, and the animals, guests, items and activities thereon, pose dangers to people and animals. Such dangers include, by way of example and not limitation, animals that can bite, trip, knock down, and fight, indoor and outdoor surfaces that may be slippery, equipment that may be slippery, equipment that can trip guests and clients who cannot control their dogs, and activities involving my dog(s) and/or other dogs that can result in injury from bites or other causes. Accordingly, I on behalf of myself, my spouse and minor children, and anyone else whom I bring onto My Two Dogs (MTD) premises, assume the risk of injuries, losses, damages, costs and expenses by any means above described, and other injuries, losses, damages, costs and expenses of every possible cause and description. If Dog is injured in a dog fight or an accident, gets fleas, ticks or worms, contracts any illness or disease, is lost or stolen, becomes pregnant, or engages in any dangerous, vicious or unwanted behavior, during or after the term of this Agreement, on or off MTD's premises, I accept the risk of the same and agree that MTD and Training Angels (TA), its Trainers and their agents shall not be held responsible for it or any resulting injuries, losses, damages, costs or expenses.

If any dog I bring into the MTD premises causes property damage, or bites or injures any dog, animal or person (including but not limited to MTD and TA, its Trainer and their agents), during or after the term of this Agreement, on or off MTD's Premises, I agree to pay all resulting losses and damages suffered or incurred by MTD, TA, its Trainers and their agents, and to defend and indemnify MTD, TA, its Trainer and their agents from any resulting claims, demands, lawsuits, losses, costs or expenses, including attorney's fees.

At MTD, TA, its Trainer and/or their agents' sole election, duties hereunder shall terminate if (a) in Trainer's sole judgment Dog is dangerous or vicious to Trainer or any other person or animal, or interferes with the training of other dogs, or (b) Client breaches any term or condition of this Agreement, (c) the dogs barking is deemed a disturbance or (d) failure to pay the proper amount for the class and/or late fees.

I will not bring any dog onto the MTD premises that: has bitten a person, has pending adjudication or administrative hearing pertaining to Dog, has been declared a dangerous or potentially dangerous dog, or vicious or potentially vicious dog, that has to be muzzled around people, or is a guard dog or protection dog.

This Agreement is binding upon Client, the spouse of Client, and the children of Client. This Agreement supersedes all prior discussions, representations, warranties and agreements of the parties, and expresses the entire agreement between Client and MTD, TA, its Trainer and their agents regarding the matters described above. The parties confirm that, except for that which is specifically written in Agreement, no promises, representations or oral understandings have been made with regard to Dog or anything else. Without limiting the generality of the foregoing, Clint acknowledges that neither MTD, TA or its' Trainer or agents have represented, promised, guaranteed or warranted that my dog can be trained, that my dog will never bite, that my dog will not be dangerous or vicious in the future, that my dog will not exhibit other behavioral problems, or that the training will last for any particular amount of time. Any remedy provided in this Agreement is in addition to any and all other remedies provided by law or equity. If any provision of this Agreement is invalid, void or unenforceable, they will be severed and the remaining provisions shall be given full force and effect.
